Application deadline: July 1, 2020 (space is limited - submit early!) *Exhibitor fee:* \$40.00

Location of Fair: The church park at **Park Place** (along Route 20) in downtown Lee

Our 20th annual craft fair will be held outdoors in the church Park. We are located along Route 20 in the heart of Lee, the “Gateway to the Berkshires,” accessible from the Mass Turnpike (Route 90 exit 2), and Routes 7, 20, and 102. We anticipate food and beverages to be sold during the day. There is no admission charge to the public and free parking is available.

What is eligible? Your hand-made crafts, quilts, jewelry, other artistic creations, and non-“ready-to-eat” foods. [*foods and other items may require special permit/license – it is your responsibility to contact the town/tri-town-health to obtain this*] **NOTE: New zero-waste regulations require that vendors use recyclable or compostable containers (no plastic bags).**

Spaces are 10' x 10', marked but not assigned. Please supply your own booth/weather protection and setup prior to 8:30 a.m. *You are required to stay for the entire length of the fair.* Craft fair workers will be available to relieve you, if necessary, throughout the day. After setting up, please move your vehicle to another parking lot so that spaces in the Park’s lot are available for people visiting the craft fair. After 8:30 a.m., vendors who are wait-listed will have access to any available spaces. Any vendor who does not show and does not contact the church may jeopardize selection in future church craft events.

To exhibit, complete the application form and return it with a \$40 non-refundable check payable to the *First Congregational Church of Lee*. (Application enclosed or from our website www.ucc-lee.org). We will notify you of receipt of application. **Fee returned if we decline your application.** Application deadline is JULY 1, 2020.
